

In the context of education, storytelling serves as a dynamic and inclusive tool that enhances learning by incorporating personal experiences, cultural traditions, and imaginative scenarios. This engagement fosters critical thinking, empathy, and a deeper understanding of the subject matter.

This approach encourages participants to engage emotionally and intellectually with the material, breaking down stereotypes and misconceptions. Through the power of stories, complex issues related to immigration and diversity become more relatable and accessible, promoting critical thinking and dialogue. By creating an inclusive environment where diverse voices are heard and respected, storytelling helps build a more cohesive and tolerant society, enhancing civic engagement and social cohesion.





Tools for tackling Immigration and tolerance through storytelling

Shaping Understanding of Migration and Tolerance

Aims & Objectives

- Explore and Understand the issues of Immigration, Emigration and Tolerance to Difference.
- Comprehend the essence of tolerance towards difference and diversity.
- Cultivate critical thinking regarding immigration, emigration and embracing diversity.
- Enhance understanding and foster positive attitudes towards immigration, emigration and tolerance.

Time: 150 min.

Materials Needed

Short summary on migration

Methodology and Techniques

This activity is based on Situated Learning – a theory involving learners in cooperative activities where they are challenged to use their critical thinking and kinesthetic abilities to acquire professional skills. The facilitator/trainer/mentor will utilize the storytelling method in order to create awareness, foster understanding, invite for reflection and discussion, spark curiosity and establish identity.

Preparation

The preliminary stage of this educational process is to cultivate an understanding of the concepts of migration, immigration and emigration. Define why people flee their countries and the push and pull factors. Explore the different aspects of



integration and assimilation and the interaction between migrants and the host society.

What do you want to achieve through this activity? Before delivering the session, educate yourself on migration and its vital aspects. Be careful (!), you must use only reliable sources, such as the International Organization for Migration (United Nations– IOM). Think about tolerance to difference from a twofold point of view: tolerance towards the migrant people and tolerance towards the host society.

Instructions & Structure of the Session

- Divide participants into two groups.
- Provide both teams with pens, markers, sticky notes and an A2 white cardboard.
- Participants will work both as a team and individually.
- Introduce participants to the topic of migration. Ask them to write down on a sticky note, "What's the first thing that comes to their minds when hearing the term "migration." Collect all the sticky notes and place them on a whiteboard visible to everyone.
- Ask participants to work in groups. Give each group a paper including a story. Let participants read the stories and ask them to identify the PUSH and PULL factors of migration. Why do people migrate? Can participants define any patterns of migration?
- Each group must choose a representative who will present their ideas about the migration PUSH and PULL factors

You can ask questions, such as:

- What is migration?
- Is there any difference between emigration and immigration?
- What makes people leave their homelands?
- What are your experiences with people from migrant backgrounds?
- Do you know any of their stories? Share your thoughts on the reasons for migration.



- What can be the biggest issue for these people entering/leaving a country?
- Discussing migration's push and pull factors with the groups, give each group another emigration/immigration story from their region/country. You can find immigration stories on the official website of UNHCR. Trainers and facilitators can also develop a story related to immigration/emigration based on their personal experiences or an interview with someone who immigrated/emigrated to/from their country.
- The stories will be distributed in a printed format. The trainer selects an individual to serve as a storyteller within each group. Once storytellers provide an overview of their respective narratives, they present them to their group in the first person singular. Following this, the trainer or facilitator can pose the following questions to the participants:

- a. What factors might prompt migration?
- b. What challenges did they encounter during their migration?
- c. What resources aided them on their journey?
- d. What kinds of attitudes did they face?

- Subsequently, both groups will exchange the insights gained from their respective discussions.
- Participants will collaborate, this time revisiting the topic of migration. Ask them to generate a word cloud focusing on migration, comparing it with the results of the initial exercise. Utilising Miro or a similar application can add visual appeal to this activity.

Debriefing

- To conclude the session and stimulate further discussion, the trainer/facilitator can pose the following questions:
- Did your perspective undergo any changes during this exercise? If so, what prompted these changes and how they were manifested?



- In your view, does your community exhibit tolerance towards immigrants? What lessons can we get from their approaches to tolerance?
- What is your stance to multiculturalism? Pros and Cons. Additionally, how do you interpret the European Union's motto, "United in Diversity"?
- How might we collaborate despite linguistic and cultural disparities? What strategies can we employ to surmount these challenges and foster cohesion?

Aim & Objectives

Learn about issues regarding tolerance to difference.

Understand what tolerance to difference entails.

Develop critical thinking on the topic of diversity, tolerance and acceptance.

Time: 90 minutes

Methodology and Techniques

The methodological background of this session is situated or situational learning. The facilitator/trainer/mentor will build on the storytelling method as a non-formal method of education. Storytelling in education creates awareness, fosters understanding, invites reflection and discussion, sparks curiosity, and establishes identity and rituals. Stories are a source of knowledge and inspiration, and by telling or listening to them, young people also develop the capacity for acceptance, they learn to accept and let go of their own prejudices. "Storytelling can be used to enhance the learning and creativity of pupils or young people in schools or youth centres. Its three stages allow the beneficiaries to be prepared for the story, to listen carefully and reflect upon its events and to draw conclusions by developing a proactive attitude where the young people are involved in the post-telling of the story. The facilitator/trainer/mentor will use the above-mentioned technique to enhance and improve the students' attitude and perception of tolerance and difference

Preparation

Think of the aims you would like to achieve with this session. Learn more about the topic of diversity, tolerance and acceptance. The main aim is to build a common understanding on tolerance and acceptance, including the relationship and difference between these two definitions. Explore the different aspects of tolerance and acceptance. See the Further Reading



part. Build your own story. You can use your own experiences, or you can find some instructions and examples on the website of the UN.

Instructions & schedule of the Session

Group exercise: Start the session with a short exercise. Divide the participants into two groups and ask them to match the following sentences to the right definition ("TOLERANCE" or "ACCEPTANCE").

- i. Individual's willingness to tolerate the existence of opinions or behaviours they dislike or disagree with
- ii. Individual's assent to the reality of a situation, recognizing a process or condition (usually a negative or unpleasant one) without protesting it or trying to change it
- iii. A kind of passive resignation
- iv. We might tolerate a person we dislike
- v. When we accept someone, we actively try to get rid of negative feelings
- vi. We want to change but do not have the power
- vii. We embrace things and show no resistance

Discuss the results with the participants.

What should be tolerated and what should be accepted in their view?

Present your story.

The story should be selected with the aim of leading the participants to the topic of tolerance and acceptance. You can use a story of your own, or other elements, such as audio and visual elements. It should create opportunities for the development of tolerance and a change of behaviour towards diversity and for finding different perspectives. The story will provide a good start to a common discussion with the participants on the topic. Invite the participants to share their stories and experiences connected to tolerance or acceptance.

- What kind of differences do you perceive with other people? Can you divide them into categories (behaviour, language, culture, food, religion, etc.)?



- What makes or does not make you tolerate or accept something?

Questions

What are the relationship and the difference between tolerance and acceptance?

How did you react? What was your perception of the difference?

Can you recall any stories regarding diversity issues? From abroad or maybe in your own region/country?

Debriefing

Ask the participants to discuss these issues with each other.

Multiculturalism & Interculturalism

Aim & Objectives

- Raising awareness on multiculturalism
- Introducing the concepts of multiculturalism, interculturalism and diversity

Methodology and Techniques

This tool is based on the method of storytelling. The method has three main elements that make up the storytelling session: the Story, the Storyteller and the Audience. When talking about the Story, one can notice that we have many types of stories: for example, personal stories, well-known stories and unwritten stories, the ones that are created on the spot, etc. Storytelling has no age limit, with regards to both Storyteller and the Audience. When we speak about a good Storyteller, we do not refer only to their artistry, to the skills that can be developed with time, but also to the relationship created with the Audience. Storytelling represents a safe and inspiring environment for those who take part, a place where they can reflect, discover, communicate, find solutions, get involved – all of this depending on how open they are willing to be. The communication between these three elements is what maintains a storytelling session, by giving power to both the people and messages involved.

Preparation

Think of the aims you would like to achieve with this session. Learn more about the topic of multiculturalism, interculturalism and diversity. The main objective is to build a shared understanding of these concepts

Instructions & schedule of the session

1. Group exercise in one group: What comes to your mind about the word „diversity“? Create a word cloud as a group
 - a. Necessary tools: post-its, paper sheets, pens
2. Individual exercise: the trainer asks the participants to create a story



about what cultural diversity means to them

a. Ask the participants to tell a personal story about when they experienced cultural diversity.

i. Necessary tools: paper sheets and pens

b. Sharing circle: the participants tell their stories to the group

i. 3–5 minutes per story

Multiculturalism, Interculturalism – awareness-raising exercise

a. The trainer puts up the above-mentioned four words/concepts (a projector, blackboard, etc.)

b. The trainer divides the participants into four groups, giving each group a definition of the above-mentioned concepts. The definition should not include the given concept, so the participants themselves should identify which definition belongs to which concept.

c. Sharing circle: how did you identify the concept in your definition? How did you pair the definition with its title? Was it easy/hard? Why?

„Yes and...” group exercise

a. The group create a story together about living together in diversity.

b. The trainer starts the exercise with the first sentence: Let's tell a story about a world that celebrates diversity. In this world, people have different cultural backgrounds, and speak different languages.

c. The next participant starts with „Yes, and...” and adds their idea.

d. When everyone told their addition to the story, the trainer ends with „ And this is the end of the story”.

Debriefing

The group reflects on the exercises with the following questions:

How do you define your own culture? Is it based on language, geography, identity or else?

Which is the most important element for you? Did your opinion change



about multiculturalism and diversity? If yes, how? If not, why?

In which situations do you experience different cultures in your daily life?

Do you have a favourite culture which is different from your own? What did you experience during the „Yes and...” exercise?

Examples: you can catalogue questions for the facilitator to ask the participants. You can give instructions on how to close the activity.

Integration & Assimilation

Aim & Objectives

- Raising awareness on the concepts of integration and assimilation
- Stimulating critical reflection on the challenges of integration and assimilation
- Inspiring actionable steps towards building more inclusive and empathetic communities

Methodology and Techniques

This tool is based on the method of storytelling. The type of storytelling that will be used is “The Two Voices of a Story” which is a collaborative storytelling technique where one person initiates a story, and two additional storytellers improvise responses to audience questions as if they were the main characters.

Preparation

Introduction (10 mins)

Begin by introducing the concept of collaborative storytelling and its relevance to understanding immigrant experiences. Emphasize the importance of empathy and perspective-taking in promoting integration and assimilation.

Setting the Stage (15 mins)

Select one participant to act as the main storyteller. This participant will begin by sharing the opening of a personal or fictional anecdote related to immigration, setting the stage for the story.

Instructions & Schedule of the Session

1. Dual Narratives (30 mins)
 - The main storyteller starts the narrative by sharing the beginning of their story, providing context and introducing key characters or themes related to immigration and assimilation.



- Two additional participants, designated as the "additional storytellers," stand behind the main storyteller and act as the voices of the main characters in the story.
- The audience is invited to ask questions about what happens next in the story, guiding the direction of the narrative.
- The two additional storytellers take turns responding to audience questions, improvising their responses as if they were the main characters experiencing the events described.
- As the story unfolds, encourage participants to explore the challenges, emotions, and decisions faced by immigrants in the process of integration and assimilation.

2. Revelation and Reflection (15 mins)

- Once the collaborative story reaches a conclusion, the main storyteller reveals the true narrative behind the initial anecdote.
- Facilitate a reflective discussion on the differences and similarities between the collaborative story and the main storyteller's actual experience or intended narrative.
- Encourage participants to consider how the collaborative storytelling process illuminated different perspectives on integration and assimilation.

3. Comparative Analysis (10 mins)

- Guide participants in comparing and contrasting the collaborative story with the main storyteller's actual experience or intended narrative.
- Discuss insights gained from the activity, including the challenges, surprises, and moments of connection revealed through the dual narrative approach.



Debriefing

Summarize key takeaways from the activity, emphasizing the importance of empathy, understanding, and perspective-taking in promoting integration and assimilation for immigrants.

Expected Outcomes

Through this activity, participants will gain a deeper appreciation for the diverse experiences and challenges faced by immigrants in their journey towards integration and assimilation. By collaboratively exploring these narratives, participants can cultivate empathy and solidarity towards immigrants and contribute to creating more welcoming and inclusive communities
